

**Hong Kong Fire Services Department**  
**Class 3 Fire Service Installation Contractor Computerised Written**  
**Examination**  
**Application Procedures**

(1) Entry Requirement

- (i) Applicants must be residents in Hong Kong and aged 21 or more.
- (ii) Applications from registered class 3 fire service installation contractors will NOT be accepted.
- (iii) Civil servant/ex-civil servant should comply with all government rules and regulations on outside work/outside employment during pre-retirement leave and post-retirement before submitting the application for registration as a class 3 fire service installation contractor.

(2) Examination Date & Time

- (i) The examinations are usually held in January, April, July and October each year. There will be multiple sessions for each quarterly examination. The examination dates and the total number of sessions will be subject to demand and availability of facilities. Candidates will be notified of the detailed arrangements at least one month before the examination date.
- (ii) The duration of each session is 45 minutes.
- (iii) Candidates must report to the examination centre 15 minutes before the examination time. NO additional time will be given to any late comer.

(3) Examination Fee

The examination fee is one thousand two hundred and eighty Hong Kong Dollars (\$1,280). Fees paid are not refundable.

(4) Application Procedures

- (i) (a) Complete and submit electronic [application form](#) via GovHK.
- (b) Complete the application form [[FS250B](#) (English version) or [FS250D](#) (Chinese version)] and submit it in person, by a representative or by post to the following address:

- (ii) Settle the examination fee upon receipt of the payment notice (to be issued within 7 days upon receipt of the application form).

Notes:

- Each applicant can submit only one application for each quarterly examination.
- Application will be accepted on a first-come-first-served basis.
- Examination places are not transferrable.

(5) Application Deadlines

<b>Month of examination</b> (including additional sessions held in subsequent months in the same quarter)	<b>Application Deadline</b>
January	15 November
April	15 February
July	15 May
October	15 August

The application form must reach this department by the above deadlines, otherwise the applicant will be assigned an examination session in the following quarter. If the deadline falls on a Saturday, Sunday or Public Holiday, it will be extended to the following working day.

This department is not responsible for any late submission due to lost or misdirected mail.

(6) Retaking the Examination

There is no limit on the number of retakes by each candidate. However, candidates are not allowed to retake in the same quarter and they are required to pay the examination fee for each retake.

(7) Absence

Candidates who are absent from Hong Kong or are prevented by illness from attending the examination may apply for retake in writing or [electronically](#) with supporting documents within two weeks from the examination date. If the applications are accepted, the candidates concerned would be arranged to sit for the examination in the next quarter without payment of a further fee.

Free retake will not be arranged for candidates who are absent under any other circumstances.
