## Advisory Letter for Annual Inspection of Building Fire Service Installation or Equipment

Pursuant to Regulation 8(b) of the Fire Service (Installations and Equipment) Regulations, Chapter 95B of the Laws of Hong Kong, the owner(s) of any fire service installation or equipment (FSI) which is installed in any premises shall have such FSI inspected by a Registered Fire Service Installation Contractor (RFSIC) at least once in every 12months.

Should the owner(s) of FSI fail to observe the aforementioned Regulation, the Fire Services Department (FSD) will issue an Advisory Letter to the owners, occupiers or management offices of those buildings to advise them of the requirement to commission a RFSIC to conduct annual inspections of the FSIs. With a view to closely monitoring the follow-up action taken by those owners, occupiers or management offices, we have prepared a report form attached to the Advisory Letter, requesting them to report the completion of the annual inspection of their building FSI. Sample of the Advisory Letter and the Report Form are enclosed in the Appendix for your easy reference.

This Letter serves to inform all RFSICs of the above arrangement and seek your collaboration to advise/help your client to conduct the annual inspection of their building FSI and to report to FSD within fourteen days upon the completion of such inspection.

This Department has not received any copy of Certificate(s) of Fire Service Installation and Equipment in the last 12 months from your hired Registered Fire Service Installation Contractor.

Pursuant to Regulation 8(b) of the Fire Service (Installations and Equipment) Regulations, Chapter 95B of the Laws of Hong Kong, the owner(s) of any fire service installation or equipment which is installed in any premises shall have such fire service installation or equipment inspected by a Registered Fire Service Installation Contractor at least once in every 12 months. Therefore, it is imperative for you to commission a Registered Fire Service Installation Contractor to conduct an annual inspection for the fire service installation or equipment of your building and keep such fire service installation or equipment in efficient working order at all times. Upon completion, the Registered Fire Service Installation Contractor shall, within fourteen days after completion of the inspection work, issue a certificate to the person on whose instruction the work was undertaken and forward a copy thereof to the Director of Fire Services.

Any person who contravenes the aforesaid regulation shall be guilty of an offence and shall be liable on conviction to a fine at Level 5 (i.e. HK\$50,000).

## Please note that this letter does not have any legal bearing on other document(s) or letter(s) issued by the Fire Services Department (FSD). If you have received other document(s) or letter(s) from FSD in connection with the fire service installation or equipment of your building e.g. Fire Hazard Abatement Notice, the requirements stipulated therein shall have to be complied with accordingly.

If an annual inspection of the fire service installation or equipment of your building has already been conducted with relevant certificate(s) issued by a Registered Fire Service Installation Contractor, please let us have your reply in the form provided at Annex with a copy of the certificate(s) within 14 days upon the completion of inspection work. The form can be returned to Senior Divisional Officer (Fire Service Installations Task Force) by fax (2724 3088) or by post.
