- (乙) 申請人有權根據《個人資料(私隱)條例》的規定，要求查閱或改正填報於本表格內的個人資料。這些要求可以書面送交香港九龍九龍灣常悅道11號新明大廈2樓消防設備專責隊伍，信封面請註明「申請閱覽消防裝置及設備圖則」。
- (B) The applicant shall have the right to request access to or correction of personal data provided herein under the provisions of the Personal Data (Privacy) Ordinance. Such requests may be made in writing to Fire Service Installations Task Force, 2/F, Centre Parc, 11 Sheung Yuet Road, Kowloon Bay, Hong Kong. - (C) The Department follows the seven Data Protection Principles in the PDO in handling personal data, and undertakes to:
- (壹) 經合法和公平的途徑收集足夠而不過量的個人資料。資料只供與處方的職能和活動有關的合法目的之用；
- (1) collect adequate, but not excessive, personal data by lawful and fair means only for lawful purposes related to the department's functions and activities;
- (貳) 採取所有切實可行的措施，確保為特定用途而收集或保存的個人資料正確無誤；
- (2) take all reasonably practicable steps to ensure that the personal data collected or retained are accurate, having regard to the purposes for which they are to be used;
- (參) 把為特定用途而收集但已不再需要的個人資料刪除；
- (3) erase personal data which are no longer necessary for the purposes for which they are to be used;
- (肆) 為特定用途而收集的個人資料，只會用於與該用途有關或直接有關的用途上，除非有關人士表明允許改變用途或這類用途合乎法規；
- (4) use the personal data collected only for the purposes or directly related purposes for which the data were to be used at the time of collection, unless the individual concerned has given express consent for a change of use or such use is permitted by law;
- (伍) 採取所有切實可行的措施，確保個人資料得到保障，不會出現未經許可或意外查閱、處理、刪除等情況或作其他用途；
- (5) take all reasonably practicable steps to ensure that personal data are protected against unauthorized or accidental access, processing, erasure or other use;
- (陸) 採取所有切實可行的措施，確保有關人士可得知處方保存的資料的種類和資料的用途；以及
- (6) take all reasonably practicable steps to ensure that a person can be informed of the kinds of personal data that the department holds and the purposes for which the data are to be used; and
- (柒) 容許資料當事人查閱或改正個人資料，並按照法例所容許或規定的方式，處理任何這類的查詢／改正要求。
- (7) permit persons to access and correct personal data of which they are the data subject and process any such access/correction requests in a manner permitted or required by law.

- (D) Provision of personal data is solely voluntary. However, if you fail to provide the necessary information as requested or have provided inaccurate information, the Department may not be able to process your application.

- (E) Viewing of Fire Service Installations Plan may be cancelled due to exigencies of the Service.
