FSD Circular Letter No. 3/97 Checklist for Fire Shutters Installation

The revised "Code of Practice for Fire Resisting Construction 1996" (FRC Code 1996) was effective on 1 August 1996. Under paragraph 10.7 of this revised Code, the Building Authority has taken over the authority to accept the construction, installation and assembly of fire shutters in private building works.

With immediate effect, the "Checklist for Fire Shutters Constructed and Installed in accordance with the Rules of the Fire Offices' Committee" as per Appendix 2 of the "Code of Practice for Minimum Fire Service Installations and Equipment and Inspection and Testing of Installation and Equipment" shall become obsolete.

This department will continue to carry out the inspection and testing of all activating devices as well as the operation of the fire shutters in accordance with the attached checklist.
