To: All Licensees of Dangerous Goods Vehicles and Dangerous Goods / Timber Stores

REMINDER: Maintenance of Fire Service Installations and Equipment

This serves to remind all Licensees of Dangerous Goods Vehicles and Dangerous Goods / Timber Stores on the proper maintenance of fire service installations and equipment (FSI). The statutory requirements for examination, testing and certification of gas cylinders used as FSI as provided in the relevant legislation are summarized and tabulated below for your reference:

	Refilling of extinguishing agent and/ or charging of fire extinguishers <i>other than</i> CO ₂ gas and clean agent fire extinguishers	
	Charging of CO ₂ gas and clean agent fire extinguishers	Supplier of portable equipment (Person holding a licence for the manufacture of relevant dangerous goods)
