

## 牌照及審批 Licensing and certification

處理消防裝置承辦商註冊事宜。為促進消防安全,該總區亦 積極加強對食肆、酒吧和卡拉OK場所等持牌/註冊處所的 執法行動,消除火警危險。

牌照及審批總區負責制定和執行消防安全政策與規例,以及 The Licensing and Certification Command formulates and enforces fire safety policies and regulations, and processes the registration of fire service installation (FSI) contractors. It also proactively steps up law enforcement actions against fire hazards on licensed/registered premises including restaurants, bars and karaoke establishments to enhance their fire safety.

## 牌照及審批總區按職能劃分為七個課別:


The Licensing and Certification Command comprises seven functional divisions:

- 危險品法例課 Dangerous Goods Legislation Division
- 危險品管制課 Dangerous Goods Control Division 2.
- 危險品執法課 Dangerous Goods Enforcement Division 3.
- 消防工程合規課 Fire Protection Engineering Compliance Division
- 消防設施監督課 Fire Protection Facilities Supervision Division 5.
- 牌照及政策課 Licensing and Policy Division 6.
- 牌照事務課 Licensing Authority Division 7.

為加快簽發牌照/證書的程序,為業界和市民帶來更大 便利,消防處於二零二四年推出電子發放牌照及證書系統 (e-IS),以發出各類具數碼簽署的電子牌照/證書及接受電 子繳費,申請人因此不再需要親身到消防處的辦事處領取牌 照/證書或繳付費用。該系統亦方便市民隨時透過政府「認 證易」的一站式平台驗證文件真偽。此外, e-IS 亦與食物環 境衞生署的電子系統對接,省卻一直以來處理相關牌照申請 時的交換文件需要。

To expedite the licence/certificate issuance procedures and to bring greater convenience to the trades and the public, the FSD launched the e-Issuance of Licences and Certificates System (e-IS) in 2024. The e-IS enables the department to issue various digitally-signed electronic licences/certificates and to receive electronic payments so that applicants are no longer required to obtain the certificates/licences or make payments at the FSD's office in person. The e-IS also facilitates members of the public by allowing them to verify documents through the Government's "e-Proof" one-stop platform anytime. Furthermore, the e-IS has also been interfaced with the Food and Environmental Hygiene Department's electronic system, eliminating the need for conventional document exchanges when processing relevant licence applications.

## 消防安全 Fire safety

消防安全總區負責制定消防安全政策,以及建築物和集體運 輸系統的消防安全措施。該總區亦致力加強市民的消防安全 意識、提升舊式建築物的消防安全裝置,以及審核消防安全 改善工程的貸款申請。

The Fire Safety Command draws up fire safety policies and formulates fire safety measures for buildings and mass transit systems. It devotes enormous effort to enhancing public awareness of fire safety, upgrading FSIs in old buildings and vetting loan applications for fire safety improvement works.

## 消防安全總區按職能劃分為九個課/組別:

The Fire Safety Command comprises nine functional divisions/units:

築物)條例》的修訂工作,而該《條例》已於二零二四年十二 月十三日刊憲實施。透過引入代辦工程機制、提升罰則,以 及協助和推動受《條例》規管的目標樓宇遵從《條例》的要求, 這些樓宇的消防安全水平可望提升至切合現代要求的防火 保障。

為提升舊式樓宇的消防安全,消防處已完成《消防安全(建 To enhance the fire safety of old buildings, the FSD has completed the amendment to the Fire Safety (Buildings) Ordinance which was gazetted and came into force on December 13, 2024. By introducing the defaulted works mechanism, increasing penalties, as well as assisting and driving target buildings regulated by the Ordinance to comply with the requirements, it is expected that the fire safety standards of the buildings can be enhanced to meet modern fire protection requirements.
